In the interactions, the nurses will outline some of the challenges they encounter when implementing or providing care using the concepts of evidence-based practice. I plan to do this interaction with patients by; making sure that that I acknowledge my patients emotions, avoid responding defensively to them and identifying what they need from me and what they care about.

According to Wolzt (2016) the scope of evidence-based practice in healthcare is viewed from the perspective of those who carry out research in relation to evidence based practice and those who use the evidence based practice information. Basing on those who carry out research in relation to evidence based practice three main steps are involved; first there is knowledge creation and distillation which involves carrying out research and recording the relevant findings into practice recommendations that ought to be put into action. The other step is dissemination and diffusion; it entails associating with healthcare organizations and professional leaders to publicize information therefore forming a commencement of action to prospective users. The final step is final user institutionalization, implementation and adoption and it ensures that teams, individuals and organizations use evidence-based research discoveries in their day to day activities (Dang, 2017)

Evidence based practice should be implemented consistently by healthcare providers in all their actions, this is because; it contains paramount evidence from studies conducted by clinical experts. In addition, when evidence based practice is carried out in an organizational culture that is supportive and caring, then maximum quality of care and great patient results can be obtained (Grobbel, 2018)

According to Scott (2015) the history of evidenced based practice in healthcare evolved in the 1800s from Florence Nightingale then in 1970s it evolved to medical physicians while in 1990s it evolved to nursing profession. Evidence based practice started as an awareness of offering improved outcomes for patients who suffered awful and unhygienic conditions and grew into a foundation in which nursing had adopted to help in offering competent and safe care to patients.

According to Dang (2017) use of evidence based practice affects people such as physicians, nurses and clerical staff. This is because, they influence how broadly and quickly the evidence based practices are put into action. There are various strategies that have been tested in relation to how the use of evidence based practice affects physicians, nurses and clerical staff and they are mainly: performance gap assessment, audit and feedback and trying of evidence based practice (Cook, 2018) the performance gap assessment informs physicians, nurses and clerical staff about the start of change and opportunities for improvement. On the other hand, audit and feedback helps physicians, nurses and clerical staff to see how their struggles in improving healthcare and patient outcomes are advancing over time. Lastly, the trying of evidence based practice enables nurses, physicians and clerical staff to try out evidence based practices obtained from research finding to see whether they will improve patient outcomes (Wolzt, 2016)

I chose World Health Organization, this is because it supports my topic by backing up sharing of awareness on evidence based practice in nursing with an aim of strengthening its foundation on healthcare professionals and healthcare policy makers. In addition, it advocates the culture of evidence based practice by assisting nurses to apply evidence based practice while carrying out their clinical roles. On the other hand, world health organization provides temporal financial assistance to its member countries with an aim of supporting the adoption of evidence-based practice in their health facilities. Moreover, World Health Organization is involved in research to support evidence based practice, this is because it believes that its adoption will lead to improved healthcare and patient outcomes (WHO, 2018) it uses it as part of accreditation requirements to ensure that patients are treated using well researched practices that will accelerate their healing process(Scott,2015)

Failure to use evidence-based practice in hospitals means that; first, there will be no consistency in healthcare, this is because it will not be based on evidence which helps in treating patients. Second, failure to use evidence-based practice implies that there will be no improved patient outcomes which become better in relation to implementation of evidence based care. Lastly failure to use evidence based care implies practitioners will not be granted independence to exercise to full of their qualifications.

The questions are supposed to be organized in the format known as PICOT, whereby letter p stands for problem of interest, patient or population; I stands for intervention being put into consideration; C stands for comparison; O stands for the measured outcomes while T stands for time to be taken to meet global and project objectives (Grobbel, 2018)

Acquiring the necessary evidence, so that I can be in a position to answer my clinical guide questions. For example, I will aim at acquiring evidence on whether exercise therapy is appropriate for assisting patients to

reduce pain after surgical procedure in comparison to medication. will do this by researching scholarly literature that relate to nursing so that I can find out whether evidence exists that can back up this evidence based practice

Appraising and applying evidence obtained in relation to the problem of interest. I will do this by reviewing the scholarly articles that I have obtained critically so that I can determine their applicability and validity as well. For example, if my patient is of old age, then the evidence that proves that exercise therapy is effective for the adolescents will not be applicable for the patient since adolescents and aged people respond to pain differently and have different requirements for controlling pain (Dang, 2017)

Lastly, I will conduct an assessment of whether my intervention was successful or not. I will do this by assessing whether carrying out exercise therapy helped in easing a patient's pain or not. In addition, I will also perform a comparison between a patient who received medication and underwent the exercise therapy and a patient who underwent the exercise therapy to find out the one who had his or her pain controlled immediately.

In for me to bring this problem to an end, I will consider two main solutions to this problem that are mainly; engaging healthcare providers in training on the importance of evidence-based practice. Lastly, I will advise healthcare of investing in skills and tools needed for forming a culture of evidence-based practice.
